The procedure for evaluation of responsive tender will be Method 4: Financial Offer, Preferences and Quality (Functionality). Evaluations of tenders will be done in two stages. Firstly, eligibility and quality (Functionality) will be assessed: where after tenders who scored a minimum of 60 % of the points or above, will be evaluated using the 80/20 Preference Point System for Financial Offer and Preference. The Preferential Procurement Policy Framework Act, 2000, (PPPFA) (Act No.5 of 2000) applies to this tender.

The Functionality will comprise of the following based on the criteria indicated in the respective tender returnable: Attach all supporting documentation.

- i. A maximum of **15 points** will be awarded for relevant qualifications and demonstrated experience of the proposed Site Agent.
- ii. A maximum of **10 points** will be awarded for qualifications and demonstrated experience of the proposed Site Foreman.
- iii. A maximum of **10 points** will be awarded for demonstrated experience with respect to undertaking construction of Building Structures and / or Sewer Installations.
