The Preferential Procurement Policy Framework Act, 2000, (PPPFA) (Act No.5 of 2000) applies to this tender.

The Functionality will comprise of the following based on the criteria indicated in the respective tender returnable: Attach all supporting documentation.

- i. A maximum of **15 points** will be awarded for demonstrated experience with respect to undertaking similar nature of work.
- ii. A maximum of **10 points** will be awarded for qualifications and demonstrated experience of the proposed Site Foreman.
- iii. A maximum of **10 points**. will be awarded for relevant qualifications and demonstrated experience of the proposed Site Agent.
